RICHMOND GOLF CLUB

Just nine miles from Central London, Richmond Golf Club is a hidden oasis of calm in the village of Petersham in Surrey.

As well as a beautiful parkland course, adjoining Richmond Park and Ham Common, Richmond Golf Club boasts a stunning, Grade I listed, early-Georgian clubhouse.

The course was originally laid out by prolific course architect, Tom Dunn, in 1891 and was substantially upgraded in recent years with the help of TPL, the firm of golf architects founded by five times Open champion, Peter Thomson. The redesign won the prestigious Golf Inc World Renovation of the Year award for 2012. At a little under 6,100 yards, the course itself is not a long one, but it presents a stiff challenge to golfers of all abilities; its narrow fairways and strategic bunkering put a premium on pin point accuracy.
