## MOVEMENT CERTIFICATE EUR I

EUR I forms give preferential import entry (usually a zero duty rate) for EU-made goods when shipped to certain markets including Albania, Algeria, Bosnia and Herzegovina, Ceuta and Melilla, Chile, Egypt, Iceland, Israel, Jordan, Lebanon, Macedonia, Mexico, Montenegro, Morocco, Norway, Serbia, South Africa, Switzerland, Syria, Tunisia and West bank / Gaza Strip.
